Our legislative labor champions were there in the struggle with us, fighting for working families and protecting them from harm. As we enter year three of this pandemic, we will be there every step of the way to ensure that the voices of working families are heard.

2021 LABOR SUPPORTED BILLS

AB 48 (Gonzalez) - Protecting Californians Against Excessive Use of Force at Protests. This bill sets clear standards on the use of rubber bullets and other kinetic impact projectiles, as well as chemical agents often used by law enforcement for crowd control during protests.

SIGNED INTO LAW. ASSEMBLY: 48-19 (9/8/2021) SENATE: 26-10 (9/2/2021)

AB 237 (Gray) - Public Employee Health Care Protection Act. This bill prohibits public employers from terminating the health care coverage of employees and their families during a strike.

SIGNED INTO LAW. ASSEMBLY: 62-9 (5/17/2021) SENATE: 30-8 (8/30/2021)

AB 257 (Gonzalez) - Protect Fast Food Workers. This bill would have responded to widespread wage theft and other abuses throughout the fast food industry by creating a Fast Food Sector Council empowered to set standards for covered workers regarding wages, hours, and working conditions.

HELD IN ASSEMBLY. ASSEMBLY: 38-27 (6/3/2021)

AB 438 (Reyes) - Layoff Parity for Classified Employees. This bill provides parity in the layoff process for classified employees and certificated employees. All school employees must now be noticed of potential layoff on or before April 29th and receive equal due process rights throughout the layoff process.

SIGNED INTO LAW. ASSEMBLY: 57-14 (5/27/2021) SENATE: 26-8 (9/7/2021)

AB 701 (Gonzalez) - Warehouse Worker Safety. This bill prohibits warehouse employers from establishing production quotas so unrealistic that workers must risk their own safety, skip meal breaks, or otherwise break the law in order to meet required goals.

SIGNED INTO LAW. ASSEMBLY: 51-19 (5/28/2021) SENATE: 26-11 (9/8/2021)

AB 794 (Carrillo) - Port Drayage and Short-Haul Truck Purchase Incentive Programs. This bill establishes specific labor standards that fleet purchasers must meet in order to qualify for incentive programs.

SIGNED INTO LAW. ASSEMBLY: 52-17 (6/2/2021) SENATE: 29-9 (9/8/2021)

AB 1074 (Gonzalez) - Displaced Janitor Opportunity Act. This bill would have required contractors and subcontractors that are award contracts to provide janitorial or building maintenance services at specified jobsites to retain certain employees employed at the same site by previous contractors and subcontractors.

VETOED BY THE GOVERNOR. ASSEMBLY: 49-20 (6/3/2021) SENATE: 23-12 (9/10/2021)

AB 1177 (Santiago) - California Public Banking Option Act. This bill establishes the CalAccount Blue Ribbon Commission, chaired by the State Treasurer, and requires the Commission to conduct a market analysis to determine the feasibility of creating a public banking program to Californians who lack banking services.

SIGNED INTO LAW. ASSEMBLY: 48-24 (6/2/2021) SENATE: 29-9 (9/8/2021)

AB 1204 (Wicks) - Medical Equity Disclosure Act. This bill requires hospitals to prepare and annually submit an equity report to the Department of Health Care Access and Information (HCAI) that includes an analysis of health status and access to care disparities for patients. All equity reports are required to be posted on the HCAI website which includes a list of hospitals that failed to submit the reports.

SIGNED INTO LAW. ASSEMBLY: 54-18 (6/2/2021) SENATE: 29-9 (9/9/2021)

AB 1550 (L. Rivas) - Protecting Bargaining Rights for University of California Employees. This bill establishes that any employee classification within the University of California system that is covered under a Collective Bargaining Agreement must retain their union representation upon the event that their classification is moved into the Academic Senate.

SIGNED INTO LAW. ASSEMBLY: 61-16 (6/2/2021) SENATE: 26-11 (9/2/2021)

SB 2 (Bradford) - Kenneth Ross Jr. Police Decertification Act. This bill establishes a process under the Commission on Peace Officer Standards and Training (P.O.S.T.) for decertification or suspension of law enforcement officers' certification following conviction of certain serious crimes or termination from employment due to misconduct.

SIGNED INTO LAW. SENATE: 26-9 (5/26/2021) ASSEMBLY: 49-21 (9/3/2021)

SB 4 (Gonzalez) - California Advanced Services Fund (CASF). This bill increases the annual funding cap for the CASF, and expands projects eligible for grants to include broadband deployment at underserved locations used for emergency response.

SIGNED INTO LAW. SENATE: 29-8 (9/9/2021) ASSEMBLY: 54-9 (9/8/2021)

SB 62 (Durazo) - Garment Worker Protection Act. This bill eliminates the piece rate system of pay within the garment industry and expands liability for wage and hour violations up the chain of production to hold brands who contract and subcontract with employers who engage in wage theft liable for violations of labor law. **SIGNED INTO LAW. SENATE: 29-9 (5/24/2021) ASSEMBLY: 49-19 (9/8/2021)**

SB 93 (Senate Budget & Fiscal Review Committee) - Right of Recall for Low Wage Workers. This bill requires large employers, including hotels, event centers, airports, and commercial buildings to offer their laid-off employees (hospitality, janitorial, and security workers) the jobs they previously held before the COVID-19 pandemic, as these businesses reopen. It narrowly applies rehiring rights only to workers who were specifically laid-off due to COVID-19.

SIGNED INTO LAW. SENATE: 25-11 (4/15/2021) ASSEMBLY: 54-19 (4/12/2021)

SB 95 (Skinner) - Supplemental Paid Sick Leave. This budget trailer bill extends COVID-19-specific paid sick leave to most workers needing time to recover from the virus, care for a sick family member, or be with a child quarantining following potential exposure.

SIGNED INTO LAW. SENATE: 29-8 (3/18/2021) ASSEMBLY: 57-19 (3/15/2021)

SB 213 (Cortese) - Workers' Compensation Presumption for Health Care Workers.

This bill would have significantly helped health care workers win indemnity and medical care benefits following occupational injury and illness.

TWO-YEAR BILL. SENATE: 20-10 (6/3/2021)

SB 270 (Durazo) - Strengthening Public Employee Organizing. This bill authorizes the Public Employment Relations Board (PERB) to enact a process of meaningful enforcement if employers refuse to provide new employee and bargaining unit lists to labor organizations as required by law.

SIGNED INTO LAW. SENATE: 30-10 (6/1/2021) ASSEMBLY: 58-15 (9/9/2021)

SB 278 (Leyva) - Public Employees Disallowed Compensation. This bill protects a retiree's already-promised and paid-for collectively bargained benefits in cases where the benefit is disallowed by CalPERS after the member has already retired. It also sets parameters for resolving future disputes over active and retired employees' collectively bargained pensionable compensation.

SIGNED INTO LAW. SENATE: 35-0 (6/1/2021) ASSEMBLY: 64-0 (9/7/2021)

SB 294 (Leyva) - Public Retirement Parity for Educators. This bill creates parity between educators and public employees by removing the 12-year limitation for CalSTRS or CalPERS service credit earned on an employer-approved compensated leave.

SIGNED INTO LAW. SENATE: 29-7 (5/3/2021) ASSEMBLY: 58-14 (8/16/2021)

SB 338 (Gonzalez) - Protect Port Truckers from Wage Theft. This bill expands and strengthens an existing law—the creation of which was sponsored by the California Labor Federation—that created a publicly accessible list of port drayage employers convicted of crimes such as wage theft.

SIGNED INTO LAW. SENATE: 29-9 (6/1/2021) ASSEMBLY: 59-18 (9/8/2021)

SB 410 (Leyva) - Streamline Worker Safety and Health Rulemaking. This bill would have eliminated a time-consuming and duplicative bureaucratic hurdle from the worker safety and health rulemaking.

TWO-YEAR BILL. SENATE: 22-9 (5/17/2021)

SB 606 (Gonzalez) - Strengthen Cal/OSHA Enforcement. This bill increases Cal/OSHA penalties for employers who either commit particularly egregious worker safety violations or endanger many workers in many places at once.

SIGNED INTO LAW. SENATE: 28-7 (6/2/2021) ASSEMBLY: 52-19 (9/8/2021)

LABOR OPPOSED BILLS

AB 1395 (Muratsuchi) - Limiting our Ability to Meet the Climate Crisis. This bill, the California Climate Crisis Act, would have set a statewide goal of net zero greenhouse gas emissions no later than 2045. This bill would have crippled investment and innovation in an industry that will be critical to meet our state's ambitious GHG goals.

TWO-YEAR BILL. ASSEMBLY: 37-0 (9/10/2021) SENATE: 14-12 (9/10/2021)
